CANDIDATES for ALUMNI BOARD VICE-PRESIDENT

Richard "Rick" Basket, Class of '95
Mark Waldo, Class of '85

Rules for the Election of Alumni Association Officers:

1. There will be five officers: President, Vice-President, Treasurer, Secretary and Sergeant-at-Arms. There may be one, non-voting, Honorary Faculty Advisor. (Elected by the alumni, or appointed by the Board.)
2. One position should be up for election each year, on reunion day.
3. The sequence for election should be the same as is listed in paragraph #1. (This year, 2005, we will start with the office of Vice-President.)
4. Prior to each election, the officers will open nominations for candidates to run for the office that is open. All alumni and faculty will be notified by newsletter and via E-mail, as to who the candidates are. The mailed newsletter, can contain candidates platform statements, and will also serve as a ballot. This ballot will be mailed to the Secretary, whose address will show on the return address. This ballot must have both a legible printed and signed name; written in blue ink.
5. For each election the officers will provide for absentee ballots by E-mail and regular mail. Main voting will be provided for at the Alumni Day meeting.
6. All three ballots: mail in, E-mail, and on site ballots, will be tabulated and permanently archived with (a) the Alumni Secretary, (b) Rachael Gil, and (c) the web master. Results will be presented at the alumni day business meeting.
7. Only Alumni and faculty members are eligible to vote or to serve as officers. (Graduation from SPA not a requirement.)
8. An incumbent may serve as many terms as they can be elected to.
9. Should a vacancy occur mid-term, the remaining officers should select someone to fill the remaining term by a majority vote of the remaining officers.
10. At any given Alumni Day business meeting, there can be a "challenge nomination" from the floor. There must be at least fifty (50) valid signatures on the written petition, and the challenger's name must appear on the petition. This will then trigger an eight week period where other candidates can be solicited to run against this "floor challenger." A full election; via mail in ballots, and via E-mail, of all alumni and all faculty will then take place and the results will be tabulated, archived, and notification of results will be sent to all alumni and faculty via mail, and E-mail. Should there not be a second candidate, other than the incumbent, to run against the "floor challenger" there will be no election. Thus, there will always at least be two candidates running for the challenged office, and this does not count the incumbent who may also run, if he or she so chooses.

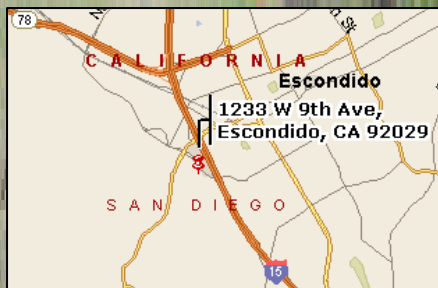
