Treasurer's Report

Our treasury balance as April 25, 2012 is \$9,964.83. That is down \$1,975.94 from last year at this time. The main reason for the decrease is the \$1,883.02 Alumni Association purchase of a portable public address system that will solve an on going P.A. system availability problem for our meetings. There were also some minor website and alumni day expenses to cover.

Another outlay is our annual \$1,000.00 grant to students of the current school. (Selected by the SPAAA officers). Our income was \$1,881.30, \$1,534 from the offering and contributions, and \$347.30 in proceeds from lunch sales.
