The board held its annual meeting on April 14, 2013 at 11:30 am. The meeting was held at Don Conibear's residence in Fallbrook, CA.

# Treasurer's Report

April 2013

The current treasury balance is **\$10,367.33**. There were very few routine expenses this year. The offering from Alumni Day services was **\$1,325.00** plus **\$232.00** from lunch which sales nicely covered the usual operating expenses.

As usual our Alumni Association made a **\$1,000.00** grant, of **\$500.00** each to two students at the current Academy. This gives us a **\$402.50** gain for the year. We hope to be able to continue the grant program in support and recognition of the current facility which carries on the education of youth, much like when we attended the facility.

We are still planning to move forward with a Grove restoration and upgrade project in the near future. We are planning to have a fund raiser in order to accomplish the planned improvements.
